### Traffic Improvement Suggestions

	Location	Description
1	City Wide	Paint curbs red 15 feet to the left and right (total of 30 feet) of all fire hydrants, per CVC 22514, so people know not to park in front of fire hydrants
2	Larkin Road, Pennington Road, Elm Street, California Street, and Broadway as defined in LOMC 10.48.060(a)	Post truck route signs so the truckers don't have an excuse as to why they're not driving on the truck routes
3	W/B Elm Street , N/B Larkin Road, and S/B Larkin Road at the Larkin Road/Elm Street intersection	Place stop signs to help prevent collisions and gridlocking
4	All highways leading into the City of Live Oak	Place city limit signs to show people where the LOMC comes into effect
5	All of Larkin Road, Pennington Road, P Street, L Street, Archer Ave. Apricot Street from Larkin Road to Samuel Street. N Street from Kola Street to Allen Street. Per the California Road Systems Map	Update traffic surveys, per CVC 40802, so we can enforce RADAR and LIDAR speeding violations
6	Fir Street in front of the old Live Oak Lockers building	Replace the missing 2 hour parking sign
7	The intersection of L Street and Fir Street	Add two more stop signs to make the intersection a 3 way stop for the purpose of slowing traffic down on L Street
8	The intersection of Archer Avenue and Sinnard Avenue	Make this a 4 way stop intersection to help prevent people from speeding
9	Highway 99 from Ash Street to lower Nevada Street	Remove or redesign the raised center medians due to the increased amount of traffic collisions
